



## Warranty | Flooring

### COVERAGE TERMS

PLAE guarantees its flooring against manufacturing defects in materials and workmanship for a specified period from sign off installation date. If a defect is confirmed, PLAE will replace the affected flooring with comparable material. While PLAE will attempt to match color and pattern, an exact match is not guaranteed. Aesthetic issues not affecting performance will receive a reasonable cosmetic remedy. See the table below for specific coverage details.

### EXCLUSIONS

This warranty does not cover:

- Damage from improper installation, abuse, or failure to follow PLAE's maintenance guidelines
- Use of flooring for purposes other than its intended application
- Defects caused by structural or sub-floor deficiencies (existing and emerging)
- Damage from excessive moisture, humidity, or lack of proper vapor barriers
- Damage from improper per-installation storage, such as exposure to extreme temperatures or unconditioned environments
- Wear in high-traffic or pivot areas
- Stains, punctures, cuts, or other accidental damage
- Color fading or changes due to prolonged sunlight exposure or environmental conditions
- Natural variations in color, shade, or pattern inherent to manufacturing or material differences
- Alterations or repairs not authorized by PLAE
- Product sold as discontinued or those sold as seconds or B-grade

### CLAIM PROCESS

To file a claim, the original purchaser must:

- Provide proof of purchase (e.g., sales receipt, order confirmation).
- Describe the issue in detail and provide pictures.

### LIMITATIONS

This non-transferable warranty applies only to the original purchaser and excludes labor, installation, and/or removal costs. In no event shall PLAE be liable for indirect, consequential, special, incidental, punitive or enhanced damages, lost profits or revenues or diminution in value or property damage, regardless of (a) whether such damages were foreseeable, (b) whether or not the customer was advised of the possibility of such damages, and (c) the legal or equitable theory upon which the claim is based, and notwithstanding the failure of any agreed or other remedy of its essential purpose.

This limited warranty is governed by the laws of Georgia, and any disputes shall be resolved exclusively in the courts of Atlanta, Georgia.
