



Warranty | Equipment

COVERAGE TERMS

PLAE stands behind its products. During the warranty period, if a defect arises in the product, PLAE may, at its discretion, repair, replace parts, or provide a new or refurbished product for the original purchaser. See the table below for specific coverage details.

EXCLUSIONS

This warranty does not cover damage caused by: normal wear and tear, misuse, abuse, improper maintenance, improper storage, or rust; accidents, neglect, or unauthorized repair; modification or alteration of the product.

CLAIM PROCESS

To file a claim, the original purchaser must:

- Contact PLAE at support@plae.global.
- Provide proof of purchase (e.g., sales receipt, order confirmation).
- Describe the issue in detail and provide pictures.

LIMITATIONS

This non-transferable warranty applies only to the original purchaser of PLAE equipment and covers only the equipment itself. Labor costs for repairs are covered for a specific period as outlined in the table below. Costs for installation, removal, and/or maintenance of the equipment are excluded. In no event shall PLAE be liable for indirect, consequential, special, incidental, punitive or enhanced damages, lost profits or revenues or diminution in value or property damage, regardless of (a) whether such damages were foreseeable, (b) whether or not the customer was advised of the possibility of such damages, and (c) the legal or equitable theory upon which the claim is based, and notwithstanding the failure of any agreed or other remedy of its essential purpose.
